The receiver incurred expenses approved by the court, pursuant a order entered MARCH 25, 2008, pursuant thereto. The receiver issued a certificate in the amount of \$5,651.53 and bearing interest at 9% annum for cost and fees, which was transferred to the City of Chicago.

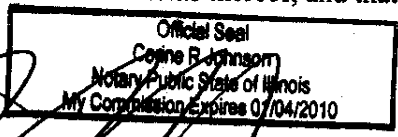
