This Agreement is by and beoven Provident (the "Lender"), and First American
Bank ("FAB"). Based on the representations and acknowledgments contained in this Agreement, FAB and Lender agree as follows:
Cynthia M Vandergriff and Barry D vandergriff Sr. (collectively "Borrower") wants Lender to provide financial accommodations to
Borrower in the form of a new credit or logn in the maximum principal amount of \$168,000,00 to be secured by a mortgage trust
deed or other security interest from Borrower to Lender on the real property as described on Exhibit "A" attached hereto (the
Premises'):
Definitions. The following words shall have the following meanings when used in this Agreement. Terms not otherwise defined in
this Agreement shall have the meanings attributed to such terms in the Uniform Commercial Code.
"FAB Lien" means that certain Mortgage affecting the Premis's dated 09/17/2003 and recorded in COOK County, Illinois as
Document No. <u>0326635269</u> , made by Borrower to FAB to secure an indebtedness in the original principal amount of \$6,000.00.
"New Lien" means that certain Mortgage affecting the Premises dated
certain Note in the principal amount of \$168,000.00, with interest at the rate of \(\frac{9}{2} \) ner annum payable in monthly installments
on the first day of every month beginning and continuing until on which date the
entire balance of principal and interest remaining unpaid shall be due and payable.

Subordination. FAB hereby subordinates its FAB Lien to the New Lien held by Lender. PROVIDED, HOWEVER, THAT THIS SUBORDINATION SHALL BE LIMITED TO INDEBTEDNESS IN FAVOR OF LENDER. IN THE PRINCIPAL AMOUNT OF \$168,000.00 AND THAT IN THE EVENT THE PRINCIPAL AMOUNT OF THE NEW LIEN IS INCREASED BY A SUBSEQUENT MODIFICATION OF THE UNDERLYING NOTE AND/OR MORTGAGE LY. LENDER, THEN THIS SUBORDINATION SHALL BE OF NO EFFECT WHATSOEVER WITH RESPECT TO ANY AMOUNTS IN EXCESS OF SAID PRINCIPAL AMOUNT, AND THE NEW LIEN SHALL BE SUBORDINATE TO THE SUBORDINATY LIEN WITH RESPECT TO ANY AMOUNTS IN EXCESS OF SAID PRINCIPAL AMOUNT.

<u>Default By Borrower</u>. If Borrower becomes insolvent or bankrupt, this Agreement shall remain in full force and effect. Any default by Borrower under the terms of the New Lien also shall be a default under the terms of the FAB Lien to FAB.

<u>Duration and Termination</u>. This Agreement will take effect when received by Lender, without the necessity of any acceptance by Lender, in writing or otherwise, and will remain in full force and effect until the New Lien is released by Lender.

Applicable Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois. No provision contained in this Agreement shall be construed (a) as requiring FAB to grant to Borrower or to Lender any financial assistance or other accommodations, or (b) as limiting or precluding FAB from the exercise of FAB's own judgment and discretion about amounts and times of payment in making loans or extending accommodations to Borrower.
