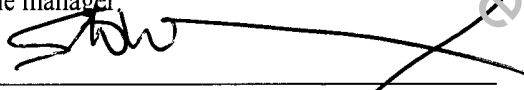
**TO HAVE AND TO HOLD** the said real estate as described above, with the appurtenances, unto the Grantee, forever.
