These agreements may require the mortgage insurer to make payments using any source of 1 inds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance premiums)

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender 'akes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captir e re nsurance." The costs of the insurance may be more than the lost of insurance Borrower may be able to obtain on its own.
