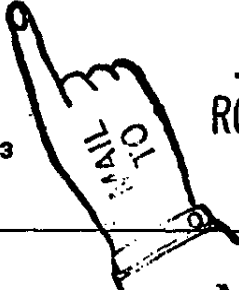

MORTGAGE
