

As a result of participation in the Senior Citizens Real Estate Tax Deferral Program, the lien, number 0615604074, was filed in the recorder of deeds' or registrar of titles' office in Cook County, on June 5, 2006. This lien can be found in the state tax lien index of that office under document number 0615604074. The lien amount of \$711.29, is comprised of the total of all deferred real estate taxes or special assessments on the 2005 tax bill, plus lien filing fees of \$26.00, and interest of \$62.01, which has accrued since the notice of lien was filed. This lien is authorized for release in the amount of \$711.29 against the real property of the participant listed above.

The property owner or his or her representative must have this certificate recorded at the recorder of deeds' or registrar of titles' office, in Chicago, Illinois, the county seat of Cook County, were this lien was filed. If the certificate is not recorded, the lien will remain on the property.
