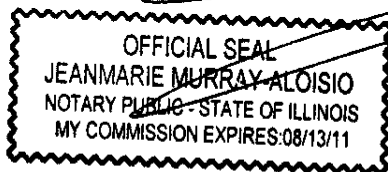

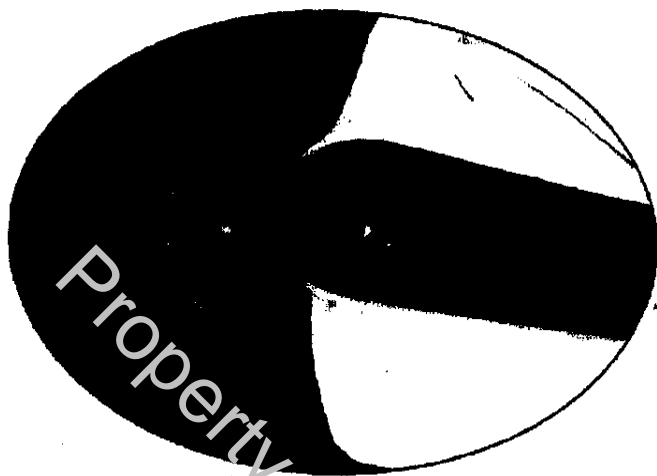

Obituary

Robert Lee Edmondson, Sr. was born September 23, 1932 in Chicago, Illinois to the late George and Willie Louise Edmondson. He was one of four children born to this union. One brother, Andrew Lee; two sisters: Alberta and Dorothy Bell preceded him in death.

Robert graduated from Morgan Park High School. After graduating he joined the National Guard, where he completed two years of college. He was employed as a Narcotics Officer, Stockyard Worker and Dockman for Local 710 for thirty years and 35th Street's favorite "Watermelon Man".

Robert accepted Christ at an early age. He became a member of Starlight St. James Missionary Baptist Church under the leadership of the late Rev. R.C. Ward. Robert continued to serve faithfully under the retired Rev. Fred Williams, and the current Pastor, Irvin L. Barrett.

On July 29, 1961, Robert married Margie McDonald who preceded him in death. He was the father of four children: Loretta, Denise, Robert, Jr. and Lovie. Robert was very close to his children and grandchildren. Robert adopted the name "Pops" which was shared by all. Pops was a strong father and grandfather figure to many community and neighborhood families. He was very active throughout the community being the Precinct Coordinator and the eldest Community Activist for the 16th Ward. After Pops' health failed him, he still was running the show from his bedside, making sure all the monthly flyers were passed out in the Second Precinct.

In addition, Pops, was a father, friend and teacher to his great-grandson "Peanut" who will miss him dearly!
