At the special instance and request of "Masters" and with the full knowledge and express consent or acquiescence of Owner(s), Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$ .00. Claimant completed providing the additional materials and labor at various umes.
- 6. That on January 15, 2008. Claimant completed and delivered substantially all work and materials required to be performed under the Subcontract.
