WHEREAS, the Declarant also desires to confirm the description of the Condominium Property submitted to the Act, which includes the additional Property being submitted by this Twelfth Amendment.

NOW, THEREFORE, pursuant to the power coupled with the interest reserved by Declarant in the Declaration, the Declarant hereby amends the Declaration as follows:

Appendix A of the Declaration is hereby amended by deleting pages 41-42 and replacing pages 41-42 of Appendix A with those pages 41-42 attached to this Twelfth Amendment as Exhibit B;

Appendix B of the Declaration is hereby deleted in its entirety and replaced with the amended Appendix B attached to this Twelfth Amendment as Exhibit C; and

Exhibit D attached hereto sets forth the description of the Condominium Property, which has been submitted to the Act.
