## MODIFICATION OF MORTGAGE

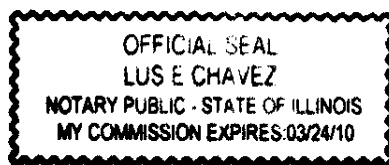
