THIS DEED OF CONVEYANCE, is made as of May ^{8th}, 2008 between **216 S. Jefferson, LLC, an Illinois Limited Liability Company ("Grantor")**, having an address of 216 S. 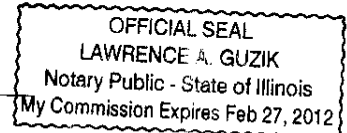
