Together with all and singular and hereditaments and appurtenances thereunto belonging, or in a ywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, and all the estate, right, one interest, claim or hereditaments and appurtenances: TO HAVE AND TO HOLD the said premises as above described, with the exprartenances, unto the party of the second part, their successors and assigns forever.

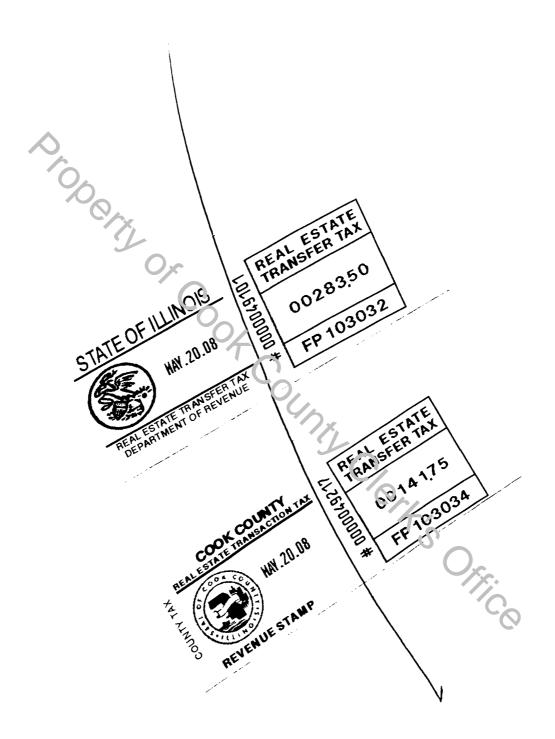
