2. Applicator of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applicately. Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order in which it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due and a this Security Instrument, and then to reduce the principal balance of the Note.

This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration or repair of the Property, the restoration or repair is economically feasible and Lender's security is not lessened. If Borrower abandons the Property, Lender may file, no jotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the foliation. The 30-day period will begin when the notice is given. In either event, or if Lender acquires the Property under Section 22 or otherwise, Borrower hereby assigns to Lender (a) Borrower's rights to any insurance proceeds in the amount not to exceed the amounts unpaid under the Note or this Security Instrument, and (b) any other of Borrower's rights (other than the right to any refund of unearned premiums paid by Borrower) under all insurance policies covering the Property, insofar as such rights are applicable to the coverage of the Property. Lender may use the insurance proceeds the insurance on the Property or to pay amounts unpaid under the Note or this Security Instrument, whether are not then due.

- 6. Occupancy. Unless it is determined pursuant to Section 5 that repair restoration is not economically feasible, Borrower shall promptly repair the Property if damaged to avoid further deterioration or damage. If insurance or condemnation proceeds are paid in connection with damage to, or the taking of, the Property, Borrower shall be responsible for repairing or restoring the Property only if Lender has released proceeds for such purposes. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. If the insurance or condemnation proceeds are not sufficient to repair or restore the Property, Borrower is not relieved of Borrower's obligation for the completion of such repair or restoration.

Protection of Lender's Interest in the Property and Rights Under this Security Instrument. If (a) Borrow of fills to perform the covenants and agreements contained in this Security Instrument, (b) there is a legal proceeding '. At alght significantly affect Lender's interest in the Property and/or rights under this Security Instrument (such as a proceeting in bankruptcy, probate, for condemnation or forfeiture, for enforcement of a lien which may attain priority over any Security Instrument or to enforce laws or regulations), or (c) Borrower has abandoned the Property, then Lender may do and pay for whatever is reasonable or appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including protecting and/or assessing the value of the Property, and securing and/or repair ng the Property. Lender's actions can include, but are not limited to: (a) paying any sums secured by a lien which has privity over this Security Instrument; (b) appearing in court; and (c) paying reasonable attorneys' fees to protect its interest in the Property and/or rights under this Security Instrument, including its secured position in a bankruptcy proceeding. Nothing in this Section 10 affects Borrower's obligation to pay interest at the rate provided in the Note.

If such agreement provides that an affiliate of Lender takes a share of the insurer's risk is exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance" rurther:
