1. Check using Payment Coupon at the bottom of this form.
 - A. Do not make any changes to the printed information on this payment coupon.
 - B. Make check payable to the Illinois Director of Employment Security - Make sure that your account number is on your check.
 - C. Complete the payment coupon by entering the amount of your check in the space provided.
 - D. Do not staple forms or payment.
 - E. Mail the payment coupon and your check in the return envelope provided.

2. Internet Payment Site using a Credit Card or Debit Card.
 - A. Have the payment coupon at the bottom of this form available when paying online.
 - B. Go to <https://www.paybill.com/IDES> and follow the step by step prompts for payment options.
 - C. You will be asked to enter the 27 digit code at the very bottom of this payment coupon.
 - D. A convenience fee will be charged to process payments. IDES does not receive any portion of the fee.

3. Telephone, using a Credit Card or Debit Card.
 - A. Have the payment coupon at the bottom of this form available when paying by phone.
 - B. Call 1-866-268-3956 and follow the step by step prompts for payment options.
 - C. You will be asked to enter the 27 digit code at the very bottom of this payment coupon.
 - D. A convenience fee will be charged to process payments. IDES does not receive any portion of the fee.
