MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated May 21, 2008, is made and executed between BOZENA E. STRZELECKA-MLECZKO, aka ELIZABETH STRZELECKA, whose address is 7460 W.
