This matter coming to be heard on the motion of Plaintiff, with Plaintiff and Defendant, Laura Walsh, having agreed to resolve their disputes, and the court being advised that a default judgment had previously been entered against both Defendants, Robert W. Walsh and Laura L. Walsh, on May 30, 2003 in the amount of \$53,507.70; that Defendant, Laura L. Walsh, subsequently challenged the judgment by motion and, after the denial of the motion, appealed the denial; the matter was then remanded by the appellate court to this court and this matter, which had originally been numbered 02 L 051079, was renumbered by administrative rule as 06 L 051246 and was eventually reassigned from Judge Lott to Judge White; Plaintiff and Defendant, Laura L. Walsh, have agreed to resolve the pending matter between them and have specifically agreed that the judgment previously entered on May 30, 2003, under case number 02 L 0 51079 be vacated and that the matter be dismissed with prejudice as to Laura Walsh only;

Based upon the foregoing,

IT IS THEREFORE ORDERED:

1. The dismissal for want of prosecution entered in case number 06 L 051246, on March 27, 2008, is vacated;
2. The judgment entered May 30, 2003 against Laura L. Walsh, in the amount of \$53,507.70 is vacated and the Plaintiff's complaint as to her, in case number 06 L 051246, is dismissed by agreement and with prejudice, and the judgment entered May 30, 2003, as to Robert W. Walsh shall stand.
3. All pending supplemental proceedings, if any, as to Laura Walsh are dismissed with prejudice.
4. There is no just reason for delaying enforcement or appeal of this order, pursuant to supreme court rule 304(a).

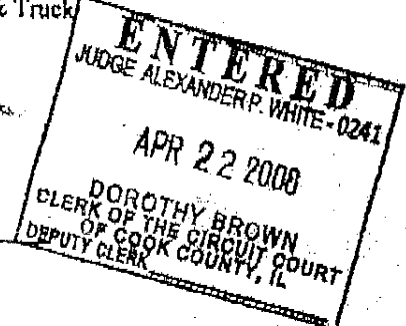
