Commonly known as: Unit PB-302, 1840 Huntington Boulevard, Hoffman Estates, Illinois 60195



Lien Claimant last performed and furnished services as General Contractor at the Property on behalf of Owner on February 22, 2008 and completed all work pursuant to the contract and the extras requested.


