On or about May 28, 2007, Owner nade a contract with Lien Claimant to perform and act as the General Contractor for the renovation of a condominium unit located on the Property for the basic compensation of One Thousand Six Hundred Twelve (\$1,612.90) Dollars and Ninety Cents, plus extras, as agreed upon between the parties and on or about March 15, 2007 and commenced work pursuant to said contract.

Lien Claimant last performed and furnished services as General Contractor at the Property on behalf of Owner on February 22, 2008 and completed all work pursuant to the contract and the extras requested.

After allowing for all credits, there is due and owing from Owner to Lien Claimant the principal sum of \$1,612.90, which principal amount bears interest at the structory rate, for which sum Lien Claimant hereby claims a Mechanic's Lien on the Property, land and improvements, together with reasonable attorney's fees as provided by the Illinois Mechanic's Lien Act.
