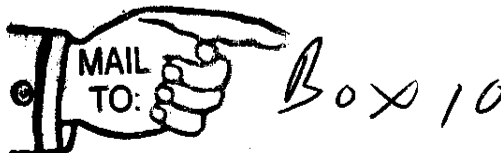
That on or about 03/12/2008, the owner owned the following described land in the County of Cook, State of Illinois to wit:




