MODIFICATION OF MORTGAGE

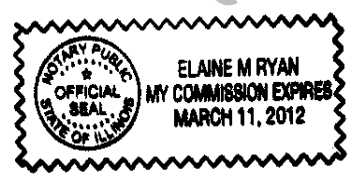

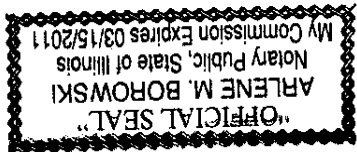
