(5) The decedent's marriage ended by the divorce decree entered in the Circuit Court of Cook County on July 20, 1989.



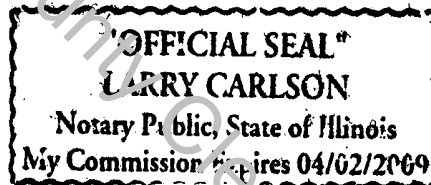
