SHORT FORM OF LEASE

THIS SHORT FORM OF LEASE ("Agreement") is made as of this June 10, 2008, by and among Catholic Bishop of Chicago, an Illinois corporation sole ("Landlord") and The Board of Trustees of the Young Men's Christian Association of Chicago, an Illinois corporation constituted pursuant to a special act of the Illinois legislature ("Tenant"). Capitalized terms used in this Agreement that are not otherwise defined herein shall have the meanings set forth in the Lease (as defined below).

- 1. <u>Demise</u>. Landlord hereby leases to Tenant, and Tenant hereby leases from Landlord, pursuant to, and in accordance with, that certain Lease Agreement dated as of the date hereof (as amended, restated, or supplemented from time to time, the "Lease") those certain portions of the parcel of land legally described in <u>Exhibit A</u> hereto, as more particularly described on <u>Exhibit B</u> hereto (the "Leased Property").
- 2. <u>Term.</u> The Term of the Lease will commence on June 10, 2008 (the "Commencement Date"), and, unless the Lease is terminated sooner or extended later, all as more particularly provided for in the Lease, shall expire on the tenth (10th) anniversary of the Commencement Date.
- 3. Exculpation. It is expressly understood and agreed by and between Landlord and Tenant, anything herein to the contrary notwithstanding, that no individual member of Landlord or Tenant, or any of their respective trustees, directors, managers, board members, officers, officials, representatives or employees (including, without limitation The Young Men's Christian Association of Chicago and its Board of Trustees and its Board of Managers), shall be personally liable for any of Landlord's or Tenant's respective obligations, undertakings or covenants contained in the Lease, all such personal liability being hereby expressly weived by the other party.
- 4. <u>Interpretation; Conflicts</u>. This Agreement does not alter, amend, modify or change the Lease in any respect. This Agreement is executed by the parties solely for the purpose of recordation in the real estate records of Cook County, Illinois, and it is the intent of the parties that it shall give notice to and confirm the Lease to the same extent as if all of the provisions of the Lease were fully set forth herein. The Lease is hereby incorporated by reference into this Agreement, and the parties hereby ratify and confirm all of the terms and provisions of the Lease. In the event of any conflict or inconsistency between the provisions of this Agreement and the provisions of the Lease, the provisions of the Lease shall control.
