MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated June 2, 2008, is made and executed between Jerry N. O'Connor and Christina A. O'Connor, his wife, Joint Tenants, whose address is 6050 N. 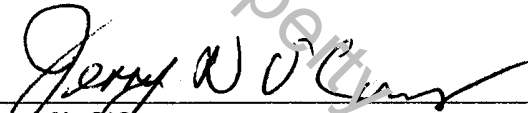

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
