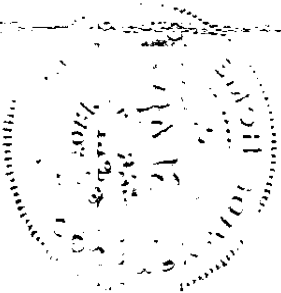

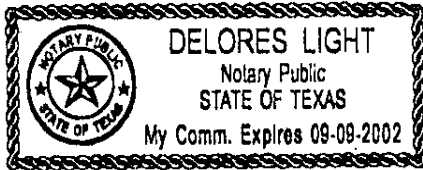

RIDER - LEGAL DESCRIPTION
