## MUNICIPAL CODE VIOLATION NOTICE

The Illinois Municipal Code 65 ILCS 5/11-31.1-12 states:

Sanctions applicable to owner – Property. The order to correct a code violation and the sanctions imposed by a municipality as the result of a finding of a code violation under this Division [65 ILCS 5/11-31.1 et al.] shall attach to the property as well as to the owner of the property, so that a finding of a code violation under one owner cannot be avoided by conveying or transferring the property to another owner. Any subsequent transferee or owner of the property takes subject to the findings, decision and order of a hearing officer under this Division [65 ILCS 5/11-31.1 et al.]

The Illinois Municipal Code 65 ILCS 5/11-31.1-1(a) defines the word code as follows:

“Code” means any municipal ordinance, law, housing or building code or zoning ordinance that establishes construction, plumbing, heating, electrical, fire prevention, sanitation or other health and safety standards that are applicable to structures in a municipality or any municipal ordinance that requires, after notice, the cutting of weeds, the removal of garbage and debris, the removal of inoperable motor vehicles, or the abatement of nuisances from private property.

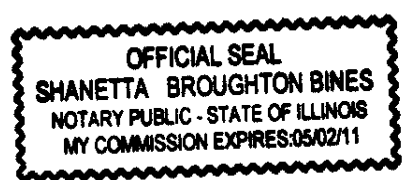
