WHEREAS, the real estate described in the Declaration, as amended, located in the County of Cook and State of Illinois has been submitted to the Condominium Property Act of the State of Illinois, as amended (the "Act") pursuant to the Declaration; and

WHEREAS, pursuant to Paragraph 14.13 of the Declaration, Declarant reserved the right to prepare a Special Amendment to correct clerical errors in the Declaration; and

WHEREAS, the assignment of limited common element Storage Lockers was erroneously omitted from the Declaration and the Plat of Survey and therefore, the Declarant desires to assign certain limited common element Storage Lockers to the Units to which the Storage Lockers are appurtenant;

WHEREAS, the Declarant desires to amend the Declaration as it relates to the Plat of Survey (Exhibit "A" thereto) in order to more specifically depict a portion of the

common elements and limited common elements, and in order to include Storage Locker designations and Storage Locker assignments.

NOW, **THEREFORE**, the Declarant, for the purposes above set forth, hereby declares that the Declaration is amended as follows:

- l. Paragraph 4.11 of the Declaration is hereby amended to provide that the exclusive use of limited common element Storage Lockers may be assigned via conveyance deed, the Declaration, or the Plat.
- 2. Exhibit "A" of the Declaration, "Plat of Survey", is hereby amended by appending thereto Exhibit "A" attached hereto and by this reference made a part hereof. Exhibit "A" lepicts a portion or portions of the Common Elements in which Storage Lockers are located, the Storage Locker designations, and the schedule of Units to which the Limited Common Element Storage Lockers are appurtenant.
- 3. All the unit owners and mortgage holders, by the Declarant, hereby consent to this Special Amendment to the Declaration pursuant to the powers set forth in the Declaration, including without limitation those powers described in Articles 4.11 and 14.13 of the Declaration.
- 4. Except as herein specifically amended, the Declaration is ratified and confirmed. In the event of any inconsistency between this Special Amendment, the Second Amendment recorded May 8, 2007 as Document Number 0712815117, the First Amendment recorded February 28, 2007 as Document Number 0705915063 to the Declaration and the Declaration, this Special Amendment shall control.
