As a rest at of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any afficiant of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized any portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in rachinge for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." Firther:
