
NOTICE OF LIEN



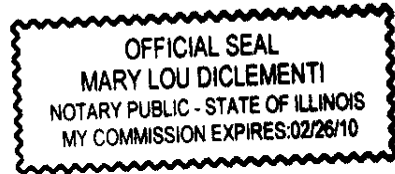
