THIS FIFTEENTH AMENDMENT is made and entered into this 30th day of June 2008, by VB 1224 Lofts L.L.C. (hereinafter referred to as "Declarant").



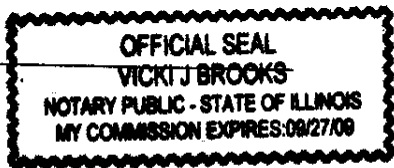
