THIS CAUSE coming on to be heard by the Court, the Court having heard evidence and testimony and having made a finding of Full Compliance (Substantial) compliance subject to reinspection (circle one) of the violations listed in the Plaintiff's complaint;

IT IS HEREBY ORDERED THAT:

- If this case is dismissed subject to reinspection, Defendant must call the assigned City inspector at (312) <sup>743</sup> ~~746~~ - 3514 within 7 days to arrange for an interior inspection of the subject premises. by 8/15/08.
- This order is final and appealable, there being no just reason to delay its enforcement or appeal.
- Defendant shall submit to a reinspection of the premises by 8/15/08.
