MODIFICATION OF ASSIGNMENT OF RENTS, LEASES AND PROFITS

THIS MODIFICATION OF ASSIGNMENT OF RENTS, LEASES AND PROFITS (this "Modification Agreement"), made as of July 1, 2008 by and between ONTARIO WEST, LLC, an Illinois limited liability company ("Grantor") and THE PRIVATEBANK AND TRUST COMPANY ("Lender").

WITNESSETH:

THAT WHEREAS, Lender made a loan in the maximum principal amount of \$8,250,000.00 (the "Loan") to the Grantor.

Repayment of the Loan is secured by the property commonly known a \$350 West Ontario and 358 West Ontario, Chicago, Illinois, pursuant to that certain Mortgage dated August 4, 2003, as amended by a Modification of Mortgage of even date herewith (the "Mortgage") and that certain Assignment of Rents, Leases and Profits recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on August 12, 2003, as Document No. 0322447049, dated August 4, 2003 ("the Assignment").

The principal balance of the Loan had been reduced to \$5,000,000.

The parties hereto desire to enter into this Modification Agreement for the purpose of modifying the Assignment to provide that repayment of the Loan, as

modified, is secured by the property that is legally described in Exhibit "A" attached hereto (the "Property").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- The recital provisions are incorporated herein by reference and made a part hereof.
- The definition of the word "Note" in the Assignment is amended in its 2. entirety as tollows:

"Mote. The word "Note" means the \$8,250,000.00 Promissory Note dated August 4, 2003 executed by Ontario West, LLC and Erie West, LLC to Lenger, as amended and restated by the \$5,000,000 Amended and Restated Promissory Note, dated July 1, 2008, executed by Ontario West, LLC and all renewals, exensions, modifications, refinancings, consolidations and substitutions thereof."

The definition of the word "Loan Amount" in the Assignment is amended 3. in its entirety as follows:

> "Loan Amount. Five Million and no/100 Dollars (\$5,000,000), together with interest and other charges as therein stated."

4. Except as hereinabove otherwise provided, all terms and provisions of the Assignment shall remain unchanged and in full force and effect and shall be binding Continue Office upon the parties hereto, their successors and assigns.
