THIS DECLARATION made and entered into this 26th day of June 2008, by and between ail the Owners and all the Members of the Board of Directors of the 1330-1332 BRUMMEL CONDOMINIUMS, hereinafter referred to as the "Declarants";

WHEREAS, the Declaration resurves to the Declarants the right to amend the Plat; and

WHEREAS, the Declarants now desire to amend ARTICLE VII(2) - "RIGHT OF FIRST REFUSAL." The Desire of the Declarants is that such Right of First Refusal be eliminated from the Declaration and that the Condoninium Association NO LONGER HAS THE RIGHT OF FIRST REFUSAL.

NOW THEREFORE, the Declarants do hereby amend the Peclaration as follows:

- ARTICLE VII (2) "RIGHT OF FIRST REFUSAL to the Declaration of 1. Condominium Ownership is hereby amended by deleting ENTIRE said ARTICLE VII (2).
- The Condominium Association NO LONGER HAS THE RIGHT OF FIRST REFUSAL.
  - All the Unit owners consent to this Amendment to the Declaration. 3.
- Except as expressly set forth herein, the Declaration shall remain in full 4. force and effect in accordance with its terms.
- This Amendment to the Declaration of Condominium ownership is 5. executed by all the owners and all the members of the

Board of Directors, in the exercise of the power and authority conferred upon them in the Declaration of Condominium ownership and its By-Laws.
