74-84-775 SECOND LOAN MODIFICATION AGREEMENT

This Loan Modification Agreement is made and entered into to be effective as of December 11, 1998, by and between ROYAL NEIGHBORS OF AMERICA, a fraternal benefit society organized under the laws of the State of Illinois ("Lender"), and SOUTH HOLLAND TRUST AND SAVINGS BANK, AS TRUSTEE UNDER TRUST AGREEMENT DATED DECEMBER 1, 1993, AND KNOWN AS TRUST NO. 10874 ("South Holland").

RECITALS

- A. Lender is the owner and holder of the Note dated January 3, 1994, in the principal sum of \$2,400,000 executed by South Holland, as mortgagor, and payable to the order of Lender, as modified by Allonge to Note dated July 1, 1997, in the principal sum of \$2,785,000, and as further modified by Second Allonge to Note of even date herewith in the principal sum of \$2,715,305.37.
- B. Lender is also the owner and holder of, among other documents, Mortgage dated January 3, 1994, made by South Holland, to Lender, filed for record in the office of the Recorder for Cook County, Illinois (the "Recorder"), on January 6, 1994, as Document No. 94015914, as modified by Loan Modification Agreement dated July 1, 1997, and filed in the office of the Recorder on July 7, 1997, as Document No. 97486475 ("the Mortgage").
- C. The parties desire to modify the Note and Mortgage as hereinafter provided, but not otherwise, and the parties hereto desire to evidence their agreements in writing upon the land records of Cook County, Illinois.

AGREEMENTS

NOW THEREFORE, in consideration of good and valuable consideration, it is agreed by and between the parties hereto as follows:

- 1. The Note is hereby modified as follows:
 - A. The interest rate is hereby decreased to Six and three-quarters percent (6.75%), and the default rate is decreased to Nine and three-quarters percent (9.75%).
 - B. The amount of the monthly principal and interest payment is hereby increased to Twenty-four Thousand Twenty-eight and no/l00 Dollars (\$24,028.00).
 - C. The maturity date of the Note is hereby extended to December 1, 2013.
- 2. The Mortgage is hereby modified as follows:

1. The payment of the Allonge to Note, as further amended by Second Allonge to Note, with a current principal balance of Two Million Seven Hundred Fifteen Thousand Three Hundred Five and 37/100 Dollars (\$2,715,305.37) and a maturity date of December 1, 2013.

All references in the original Mortgage to the Note include the Allonge to Note and the Second Allonge to Note.

All other terms and conditions of the amended Note and the Mortgage, except as modified herein, remain unchanged.
