AN ORDINANCE ESTABLISHING SPECIAL SERVICE AREA #6 FOR WEST DEMPSTER STREET IN THE VILLAGE OF SKOKIE

WHISE EAS, the Village of Skokie is an Illinois home rule municipality pursuant to Article VII, Section 6, of the Illinois Constitution 1970; and

WHEREAS, as an Illinois home rule municipality the Village may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare; and

WHEREAS, Special Service Areas are to be established pursuant to Article 7, Section 6 of the Illinois Constitution of 1970, the Special Service Area Tax Act, Illinois Compiled Statutes, Chapter 35, Section 200/27-5 et seq. (2002); and

WHEREAS, in 2002 the Village established the West Dempster Street Business Redevelopment District with the adoption of Ordinance 02-2-Z-3067 to encourage redevelopment and attract sound and stable commercial growth, and the creation of Special Service Area #6 will further the purposes of the Redevelopment District; and

WHEREAS, the Village has previously adopted Ordinance 04-11-F-3317 proposing the establishment of Special Service Area #6 in the West Dempster Street Business Redevelopment District and conducted a public hearing or December 20, 2004, pursuant to statutory notice, and no valid or timely objecting petition having been filed;

WHEREAS, the Village desires to establish Special Service Area #6 within the West Dempster Street Business Redevelopment District, previously created and established by Ordinance #02-2-Z-3067, and within the municipal boundaries of the Village, as legally described below in Section 2 of this Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Illinois, as follows:

Section 1: The Mayor and Board of Trustees make the following findings:

A. The question of the establishment of the area hereinafter described in Section 2 of this Ordinance, as a special service area is considered by the Village Board pursuant to Village Ordinance Number 04-11-F-3317 entitled "AN ORDINANCE PROPOSING THE ESTABLISHMENT OF SPECIAL SERVICE AREA #6 FOR WEST DEMPSTER STREET IN THE VILLAGE OF SKOKIE AND PROVIDING FOR A PUBLIC HEARING AND OTHER PROCEDURES IN CONNECTION THEREWITH", adopted November 15 2004 and is considered pursuant to notice duly published in the SKOKIE REVIEW on December 2, 2004, a newspaper

published in the Skokie area, at least fifteen (15) days prior to the public hearing. Furthermore, it is consider pursuant to notice by mail addressed to the person or persons in whose name the general taxes for the last preceding year were paid on each lot, block, tract or parcel of land lying within the Special Service Area. Said Notice was given by depositing said Notice in the United States mails not less than ten (10) days prior to the time set for the public hearing. In the event taxes for the last preceding year were not paid, the Notice was sent to the person last listed on the tax rolls prior to that year as the owner of the property. A Certificate of Publication of said Notice is attached hereto, marked Exhibit "A" and hereby made a part of this Ordinance. An Affidavit of mailing of said Notice is attached hereto, marked Exhibit "B" and hereby made a part of this Ordinance.

- B. That a public hearing on the question set forth in the Notice was held on December 20, 2004. All interested persons were given an opportunity to be heard on the question of the creation of the special service area and on the tax levy as set forth in the Notice. The Public Hearing was adjourned on December 20, 2004.
- C. That after considering the data, as presented at the Public Hearing, the Village Mayor and Board of Trustees find that it is in the public interest and in the interest of the Village of Skckie Special Service Area #6 that said special service area, as hereinafter described, be established.
- D. That said area is compact and contiguous and constitutes a commercial area of the Village of Skokie. An accurate map of said area is attached hereto, marked Exhibit "C" and hereby made a part of this Ordinance.
- E. That said area is zoned for commercial and mixed use purposes and will benefit specially from the municipal services to be provided. That the proposed municipal services are in addition to municipal services provided to the Village of Skokie as a whole and it is, therefore, in the test interests of the Village of Skokie that the levy of special taxes against said area for the services to be provided.
- F. No valid or timely petition objecting to the creation of the special service area or the levy of taxes as proposed, signed by at least fifty one percent (51%) of the electors residing within the special service area and by at least fifty one percent (51%) of the owners of record of the land included within the boundaries of the proposed Special Service Area #6, was filed with the Village Clark within sixty (60) days following the final adjournment of the public hearing held or Cecember 20, 2004.

<u>Section 2</u>: A Special Service Area to be known and designated as "Village of Skokie Special Service Area #6" is hereby established and shall consist of the following described territory with the following Permanent Index Numbers:

Section 3: The purpose of the formation of Skokie Special Service Area Number Four in general is to provide special municipal services to the area of West Dempster Street Business Redevelopment District, including but not limited to the installation and maintenance of roadway and sidewalk improvements, landscaping, public signage, pedestrian appurtenances, and street lighting, all within the right-of-way in the special service area. These municipal services are unique and are in addition to the services provided by the Village generally. Annual taxes shall be assessed and levied for said special municipal services on property in said Area in addition to all other municipal taxes, provided that the special annual taxes shall be levied for a period not to exceed ten (10) years and not to exceed an amount of one percent (1%) per annum of assessed value, as equalized, to be levied against the real property included in the special service area.

<u>Section 4</u>: A certified copy of this Ordinance including an accurate map of the boundaries of the special service area herein created shall be filed with the County Clerk of Cook County and duly recorded in the office of the Recorder of Deeds for Cook County.

Section 5: If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of

competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 6: This Ordinance shall be in full force and effect from and after its passage, approval and recordation as provided by law.
