RELEASE

THIS RELEASE OF MEMORANDUM OF PURCHASE AGREEMENT, is effective as of this 11th day of July, 2008, and is made by and between Robert Schwake Stone Co., Inc., an Illinois corporation ("Seller"), and Remington Homes, L.L.C., an Illinois limited liability company ("Buyer").

RECITALS:

A. Buyer and Seller are parties to that certain Purchase Agreement having an effective date of December 9, 2005, as amended on or about April 11, 2006, August 11, 2006, October 4, 2006, November 2, 2006, November 8, 2006 and November 16, 2006 (hereinafter collectively referred to as the "Agreement"), relating to real estate situated in the City of Des Plaines, Illinois and legally described on Exhibit "A" (the "Property"):

B. Seller consented to the recordation in the Recorder of Deeds of Cook County, Illinois (the "Recorder of Deeds") of a Memorandum of Purchase Agreement (the "Memorandum") on the condition that Buyer deliver to Seller an executed and acknowledged copy of this Release to be held in trust by Seller pending expiration or termination of the Agreement, and following expiration or termination of the Agreement, upon five (5) business days prior written notice to Buyer, is to be recorded in the Recorder of Deeds. Seller hereby represents and warrants to Buyer and any other party in interest that Seller has delivered the foregoing written notice to Buyer and five (5) business days have elapsed since the delivery of the same.

D. The Memorandum was recorded on or about January 23, 2008 at the Recorder of Deeds, and the Contract expired and/or terminated on or about July 11, 2008 (the "Termination Date").

NOW THEREFORE, each of Buyer and Seller hereby declare and acknowledge and agree that the Agreement has expired and/or terminated as of the Termination Date, and do hereby release the Memorandum.

IN WITNESS WHEREOF, each of Buyer and Seller have duly executed this Release as of July 11, 2008.

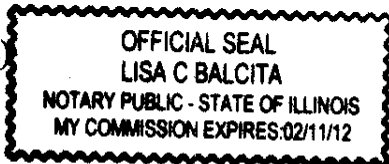

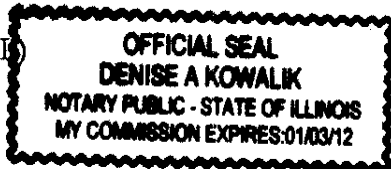
