This Power of Attorney shall become effective with respect to any Mortgage Loan and related Property upon the recordation thereof in the jurisdiction in which such Property is located, and shall be revoked with respect to such Mortgage Loan and related Property upon Clort's Office recordation of any instrument of revocation in such jurisdiction.
