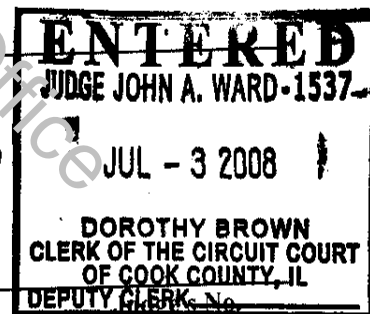

### ORDER OF DEFAULT

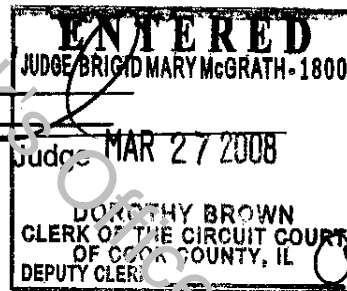
This matter coming before the Court on Plaintiff's Special Routine Motion for Default Judgment, and the Court being advised in the premises;
