Agreement for Partial Release of Mortgage, Security Agreement, Assignment of Rents and Leases and Fixture Filing

This Agreement for Partial Release of Mortgage Security Agreement, Assignment of Rents and Lease and Fixture Filing ("Agreement") is dated as of May 29, 2008 by LaSalle Bank National Association ("Mortgagee").

RECITALS

WHEREAS, Monarch Asphalt Co., an Illinois corporation ("Monarch") owns that certain parcel of vacant land consisting of approximately 0.8792 acres which is generally located at 3219 Oakton Street, Skokie, Illinois 60076 and which is legally described in Exhibit A attached hereto and made a part hereof ("Property");

WHEREAS, Monarch executed that certain Mortgage, Security Agreement, Assignment of Rents and Leases and Fixture Filing in favor of Mortgagee dated January 11, 2006 and recorded on January 18, 2006 as Document 0601843393 to secure a revolving credit facility in the amount of \$15,000,000.00 and a term loan in the amount of \$20,000,000.00 ("Mortgage");

WHEREAS, Mortgagee has agreed to the partial release of the Mortgage solely with respect to the Property.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Mortgage hereby agrees to the above recitals and further agree as follows:

- Partial release of Mortgage. Effective on the date of this Agreement, Mortgagee does hereby release the Property from the Mortgage and agrees that the burdens of the Mortgage shall no longer be appurtenant to and run with the Property or be binding upon the Property.
- Covenant Running With the Land. All provisions of this Agreement, including the benefits and burdens set forth herein, shall run with the land and are binding upon and shall inure to the benefit of the successors and assigns of the parties hereto.
- Entire Agreement This Agreement (together with the Exhibit attached hereto 3. and made a part hereof) constitutes the entire agreement between the parties pertaining to the subject matter herein and supersedes all prior agreements, understandings, negotiations and discussions, whether oral or written, of the parties hereto. This Agreement may not be amended except by an instrument in writing signed by each of the parties hereto. No amendment, ici. supplement, modification or waiver of this Agreement shall be binding unless executed in writing by the party to be bound.
