ORDINANCE 2006-88

ESTABLISHING SPECIAL SERVICE AREA NO. 86 IN THE CITY OF PARK RIDGE, COOK COUNTY, ILLINOIS AND PROVIDING FOR OTHER PROCEDURES IN CONNECTION THEREWITH

WHEREAS, the Constitution of the State of Illinois, 1970, and 35 ILCS 200/27-5 et.seq., establish the authority of municipalities to designate special service areas within the boundaries of home rule municipalities; and

WHEREAS, as the result of continuous public planning effort for the redevelopment of Park Ridge, there has been the public expression of support for the creation of a special service area for improvement of the public arter between Washington Avenue and Ashland Avenue, from Cherry Street to Elm Street; and

WHEREAS, the City Council of the City of Park Ridge, a home rule municipality, finds:

- A. That it is in the public interest that there be created the area hereinafter described as a special service area for the purpose set forth hereafter; and
- B. That said area is situated entirely within the City of Park Ridge and is contiguous; and
- C. That said area will benefit specially from the improvements to be provided, in addition to any benefit to the City of Park Ridge as a whole, and it is, therefore, in the best interest of the City of Park Ridge that tax be levied in said are a for the improvements to be provided; and

WHEREAS, a public hearing was held on the 5th dry of June, 2006 in the Council Chambers of Park Ridge City Hall, 505 Butler Place, Park Ridge, Illinois to consider the Creation of Special Service Area No. 86 of the City of Park Ridge, and

WHEREAS, NOTICE OF SAID HEARING WAS GIVEN AS REQUIRED BY 35 ILCS 200/27-5

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Park Ridge, Cook County, Illinois that the City of Park Ridge Special Service Area No. 86 is hereby established consisting of the territory described below and shown in the map attached hereto as Exhibit A:

Lot 1, Lot 3, the South 45 feet of Lot 4, Lot 5, the South 45 feet of Lot 6, Lots 7 through 12, the South 22.5 feet of Lot 13 and Lots 14 through 16 in Block 1 in the re-subdivision of Parts of Blocks 1, 3, 4 and 5 in Penny and Meacham's Subdivision of the South East ¼ of Section 26, Township 41 North, Range 12, East of the Third Principal Meridian; Lot 1 in Davie's Resubdivision of the North 72.5 feet of Lot 13 in Block 1 in the re-subdivision of Parts of Blocks 1, 3, 4 and 5 in Penny and Meacham's Subdivision, aforesaid; and Lots 1 and 2 in resubdivision of Lot 2 in Block 1 in the re-subdivision of Parts of Blocks 1, 3, 4 and 5 in Penny and Meacham's Subdivision, aforesaid; all in Cook County, Illinois. Except there from land taken for public right of way.

BE IT FURTHER ORDAINED that the City Manager is hereby authorized and directed to take such steps as necessary to effectuate the provisions of this ordinance.

This ordinance shall be in full force and effect from and after its adoption and approval as provided by law, providing no petition is filed opposing creation of the Special Service Area, pursuant to 35 ILCS 200/27-55.

BE IT FURTHER ORDAINED that the City Clerk is hereby authorized and directed to publish said ordinance in pamphlet form according to law.
