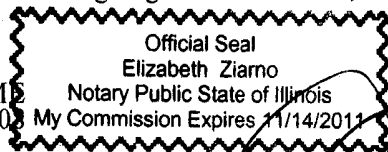

The receiver incurred expenses approved by the court, pursuant a order entered June 5, 2008, pursuant thereto. The receiver issued a certificate in the amount of \$7,086.92 and bearing interest at 9% annum for cost and fees, which was transferred to the City of Chicago.

Claimant, City of Chicago, claims a lien on the above cited real estate for the amount of \$7,086.92 plus statutory interest. The city hereby reserves the right to amend this lien from time to time to include additional cost & fees. 
