DEFAULT JUDGMENT AND FINAL ORDER

This matter comes before the Court on Plaintiff's Motion for Default Judgment and Final Order and Brief in Support Thereof (the "Motion"). Having reviewed the Motion as well as the entire record before it, this Court finds and concludes upon evidence presented that:

- That REGIONS BANK, an Alabama banking corporation, d/b/a REGIONS

 FUNDING ("Regions"), filed its Complaint (the "Complaint") against

 AMERICAN LENDING GROUP, INC. ("American Lending") and WARIN

 KUMAR, individually ("Kumar") (American Lending and Kumar collectively

 "Defendants") on December 3, 2007:
- (2) That Kumar was served with Summons and Complaint via notorious service by a St. Charles County, Missouri Sheriff's Deputy on December 12, 2007 as evidenced by that certain Affidavit of Foreign Service, the original of which is of record in this case;

- (3) That American Lending was served with Summons and Complaint via its registered agent by a St. Louis County, Missouri Sheriff's Deputy on December 17, 2007, as evidenced by that certain Officer's Affidavit of Service, the original of which is of record in this case;
- (2) That Regions agreed to extend Defendants' time for filing answers to the

 Complaint until January 22, 2008, although no formal stipulation was filed as

 Defendants have not retained local counsel, which such date was more than thirty

 (30) day, after Defendants were served, the time prescribed by law;
- (5) That Defendants failed to file answers or otherwise respond to the Complaint by January 22, 2008;
- (6) That the case became in default on January 22, 2008, by reason of the failure of Defendants to answer or otherwise respond to the Complaint; and
- (7) The total amount of Regions' damages are liquidated and insofar as Regions' claims are ex contractu (i.e., arise in contract), and not ex delicto (i.e., do not arise from tort), no hearing on damages as would otherwise be mandated by O.C.G.A. § 9-11-55(a) is required in this instance.

Therefore, it is hereby ORDERED and ADJUDGED that:

The Motion for Default Judgment and Final Order is GRANTED in favor of Regions and against American Lending; it is further ORDERED and ADJUDGED that:

- (3) Fees in the amount of \$2,400.00;
- (4) Overdrawn demand deposit account in the amount of \$42,487.83;
