- 2. That to the best of Claimants knowledge and belief PB Development Company, Inc. ("PB Development") was Owner's Contractor for the improvements at the premises.
- 3. That "PB Development" entered into an oral Contract with "Northern Illinois Brick" whereby Claimant agreed to furnish brick and masonry materials to "PB Development" in exchange for payment in the Original Contract amount of One-Hundred and Thirty-Four Thousand, Three-Hundred and Forty-One Dollars & 13/100, (\$134,341.13).
- 4. That the Contract was entered into between "PB Development" and "Northern Illinois Brick" with the full knowledge and consent of the Owner. Alternatively, the Owner specifically authorized "PB Development" to sater into Contracts for, and in said improvement of the Real Estate. Alternatively, the Owner knowingly permitted "PB Development" to enter into Contracts for, and in said improvement of the Real Estate.
- 5. At the special instance and request of "PB Development" and with the full knowledge and express consent or acquiescence of Owner, Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$227.53. Claimant completed providing the additional materials and labor at various times.
- 6. That on April 11, 2008 Northern Il inols Brick completed substantially, and did deliver all work and materials to be performed under the Subcontrac.
  - 7. That "PB Development" is entitled to credits for payments in the amount of \$114,260.00.
- 8. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by "PB Development" the balance of Twenty Thousand, Three-Hundred and Eight Dollars & 66/100, (\$20,308.66), for which with interest, Claimant claims a lien on the Peal Estate and on the monies or other considerations due, or to become due from the Owner to PB Development Company, Inc.
