MORTGAGE AND ASSIGNMENT OF LEASES AND RENTS AND UCC FIXTURE FILING

This Mortgage and Assignment of Leases and Rents and UCC Fixture Filing (this "Mortgage") is made as of the 30th day of July, 2008, by Leonard Searcy, an individual ("Mortgagor"), to and for the benefit of CONTINUUM CAPITAL FUNDING, LLC, an Illinois limited liability company ("Continuum").

Article 1

DE'-INITIONS

- 1.1 <u>Definitions.</u> As used herein, the following terms shall have the following meanings:
- (a) <u>Awards</u>: All awards and payments made or nareafter to be made by any municipal, township, county, state, Federal or other governmental agencies, authorities or boards or any other entity having the power of eminent domain to Mortgagor, including, but not limited to, any a vards and payments for any taking of all or a portion of the Mortgaged Property, as a result of, or by agreement in auticipation of, the exercise of the right of condemnation or eminent domain, or for any change or changes of grade of streets affecting the Mortgaged Property.
 - (b) <u>Borrower</u>: Leonard Searcy, an individual, and its successors and assigr s.
- (c) <u>Building</u>: All buildings, improvements, alterations or appurtenances now, or at any time hereafter, constructed or located upon the Land or any part thereof.
 - (d) <u>Event(s) of Default</u>: The happenings and occurrences described in Article 5 of this Mortgage.
- (e) <u>Guaranty</u>: The Guaranty dated of even date herewith executed by Mortgagor to and for the benefit of Mortgagee, together with any and all extensions, renewals, modifications and amendments.
- (f) <u>Impositions</u>: All real estate and personal property taxes and other taxes and assessments, water and sewer rates and charges, and all other governmental charges and any interest or costs or penalties with respect thereto, which at any time prior to or after the execution of this Mortgage may be assessed, levied, or imposed upon the Mortgaged Property or the rent or income received therefrom or any use or occupancy thereof.
 - (g) <u>Indebtedness</u>: All amounts, payments and premiums payable under the Guaranty or relating to or

arising out of this Mortgage, or any amendments, modifications, renewals and extensions of any of the foregoing.

- (h) <u>Land</u>: The real estate described in <u>Exhibit A</u> attached hereto and commonly known as **3436 S. Giles Ave., Chicago, Illinois 60616.**
- (i) <u>Leases</u>: Any and all leases, subleases, licenses, concessions or grants of other possessory interests now or hereafter in force, oral or written, covering or affecting the Mortgaged Property, or any part thereof, together with all rights, powers, privileges, options and other benefits of Mortgagor thereunder.
- (j) <u>Loan Documents</u>: The Note and other related loan documents entered into by Borrower with or for the benefit of Mortgagee in connection with Borrower's ownership and construction of certain improvements on the property located at 3436 S. Giles Ave., Chicago, Illinois.
 - Mortgaged Property: The Building and the Land, together with:
 - all rights, privileges, permits, licenses, tenements, hereditaments, rights-of-way, easements, appendages and appurtenances of the Buildings belonging or in any way appertaining thereto and all right, title and interest of Mortgagor in and to any streets, ways, alleys, strips or gores of land adjoining the Land or any part thereof;
 - (ii) all the estate, right, title, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to the Lan J, the Building, the Leases and the Rents; and
 - (iii) all the estate, right tit'e, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to the Awards, or payments with respect to casualties.
- (I) <u>Mortgagee</u>: Continuum Capital Funding, LLC and its successors and assigns and the holders, from time to time, of the Note.

- (n) <u>Mortgagor</u>: Leonard Searcy and his heirs, administrators, executors, successors and assigns, and their successors in interest in and to the Mortgaged Property.

- (p) Note: The Note dated of even date herewith executed by Borrower to the order of Mortgagee in the principal amount of ONE HUNDRED TWENTY FIVE THOUSAND AND NO/100 DOLLARS (5^1 $\angle 5$,000.00), together with any and all extensions, renewals, modifications and amendments.
- (q) <u>Obligations</u>: Any and all of the covenants, promises and other obligations (other than the Indebtedness) made or owing by Mortgagor under this Mortgage, and any and all extensions, renewals, modifications and amendments of any of the foregoing.
- (r) <u>Permitted Encumbrances</u>: The encumbrances affecting the Mortgaged Property described, with particularity, in <u>Exhibit B</u> attached hereto.
- (s) Rents: All of the rents, revenues, income, profits, deposits, tenders and other benefits payable under the Leases and/or arising from the use and enjoyment of all or any portion of the Mortgaged Property.

Article 2

GRANT

- 2.1 Grant. To secure the payment of the Indebtedness and the performance and discharge of the Obligations, Mortgagor by these presents hereby grants, bargains, sells, assigns, mortgages, conveys, hypothecates and warrants unto Mortgagee the Mortgaged Property, subject, however, to the Permitted Encumbrances, to have and to hold the Mortgaged Property unto Mortgagee, its successors and assigns forever.
- 2.2 <u>Condition of Grant</u>. Provided always, that if Mortgagor promptly shall observe, perform and discharge the Obligations, then this Mortgage and the estate and rights hereby granted shall cease, terminate and become void, and shall be released by Mortgagee, at the cost and expense of Mortgagor, and, in case of failure of the Mortgagee to so release this Mortgage, all claims for statutory penalties are hereby waived.
- 2.3 <u>Doctrine c. Merger</u>. Upon the foreclosure of this Mortgage, no assigned Lease shall be destroyed or terminated by application of the doctrine of merger or as a matter of law unless Mortgagee or any purchaser at such foreclosure sale so elects. No action or on behalf of Mortgagee or any such purchaser shall constitute a termination of any assigned Lease unless Mortgagee or such purchaser gives written notice thereof to the applicable tenant or subtenant.

Article 3

ASSIG'VIV'ENT OF LEASES AND RENTS

In order to further secure payment of the Indeptedness and the observance, performance and discharge of the Obligations, Mortgagor hereby absolutely and irrevocably a signs and transfers to Mortgagee, all of Mortgagor's right, title and interest in and to any Leases and the Rents, whether row or hereafter existing, subject only to the Permitted Encumbrances. Mortgagor hereby appoints Mortgagee its true and lawful attorney-in-fact, with the right, at Mortgagee's option at any time, to demand, receive and enforce payment, to give receipts, releases and satisfactions, and to sue, either in Mortgagor's or Mortgagee's name, for all Rents. Notwithstanding the rolegoing assignment of Leases and Rents, so long as no Event of Default has occurred which remains uncurred, Mortgagor shall have a license (such license to be deemed revoked upon the occurrence of an Event of Default) provided that the existence or exercise of such right of Mortgagor shall not operate to subordinate this assignment to any subsequent assignment, in whele or in part, by Mortgagor, and any subsequent assignment by Mortgagor shall be subject to the rights of the Mortgagee hereunder. This Assignment shall not be deemed or construed to constitute Mortgagee as a mortgagee in possession nor obligate Mortgagee to take any action or to incur expenses or perform or discharge any obligation, duty or liability. Exercise of any rights under this Article and the application of the Rents to the Indebtedness or the Obligations shall not cure or waive any Event of Default.

Article 4

COVENANTS

- 4. <u>Covenants</u>. Until the Indebtedness has been paid in full and all Obligations have been performed, Mortgagor hereby covenants and agrees as follows:
- 4.1 <u>Compliance with Laws</u>. Mortgagor will promptly and faithfully comply with, conform to and obey all present and future laws, ordinances, rules, regulations and requirements of every duly constituted governmental authority or agency, whether or not such law, ordinance, rule, order, regulation or requirement shall necessitate structural changes or improvements or interfere with the use or enjoyment of the Mortgaged Property.
- 4.2 <u>Payment of Impositions.</u> Mortgagor will duly pay and discharge, or cause to be paid and discharged, the Impositions, such Impositions or installments thereof to be paid prior to the day before any fine, penalty, interest or cost may be added thereto or imposed by law for the non-payment thereof; provided, however, that if, by law, any Imposition

may be paid in installments, Mortgagor may pay the same in such installments.

- 4.3 <u>Repair.</u> Mortgagor will keep the Mortgaged Property in good order and condition and make all necessary or appropriate repairs, replacements and renewals thereof and will use its best efforts to prevent any act or thing which might impair the value or usefulness of the Mortgaged Property, and Mortgagor will obtain the written consent of Mortgagee prior to making any alterations or additions to the Mortgaged Property.
- 4.4 <u>Insurance</u>. Mortgagor will maintain insurance upon the Mortgaged Property against loss by fire and such other hazards, casualties and contingencies as are normally and usually covered by extended coverage policies in effect in the locality where the Mortgaged Property is situated and such other risks as may be specified by Mortgagee, from time to time, in amounts and with insurers reasonably acceptable to Mortgagee but not less the amount of the Indebtedness.
- 4.5 Performance of Leases and Other Agreements. Mortgagor will duly and punctually perform all covenants and agreements expressed as binding upon it under any Lease or Leases now or hereafter existing and other agreements to which it is a party with respect to the Mortgaged Property or any part thereof, and will use its best efforts to enforce or secure the performance of each and every obligation and undertaking of the respective lessees under the Lease, and will appear and defend, at its contend expense, any action or proceeding arising under or in any manner connected with the Lease or the obligations and undertakings of the lessor thereunder. Mortgagor will immediately notify Mortgagee in writing of any notice of any material default received by Mortgagor from the Lessee thereunder.
 - 4.6 <u>Inspection.</u> Mortgagor will permit Mortgagee, at all reasonable times, to inspect the Mortgaged Property.
- 4.7 <u>Hold Harmless.</u> Mortgagor will employ legal counsel acceptable to the Mortgagee, and will defend and hold Mortgagee harmless from any action, proceeding or claim affecting the Mortgaged Property, or the validity of the Note. Mortgagor shall appear in and defend (or pay the reasonable expenses of Mortgagee to defend, if Mortgagor elects to allow Mortgagee to handle such defense) any action or proceeding purporting to affect the security of this Mortgage and/or the rights and/or powers of Mortgagee hereunder, and Mortgagor shall pay all costs and expenses (including costs of evidence of title and attorneys' fees) in any action or proceeding in which Mortgagee may so appear and/or any suit brought by Mortgagee to foreclose this Mortgage, to enforce any obligations secured by this Mortgage, and/or to prevent the breach hereof. Mortgagor's obligations under this Section 4.7 shall survive payment of the Indebtedness.
- 4.8 Existing and Additional Financing. Mortgagor shall not, without the prior written consent of Mortgagee, incur any additional indebtedness, or create or permit to be created or to remain any mortgage, pledge, lien, lease, encumbrance or charge on, or conditional sale or other title retention agreement, with respect to the Mortgaged Property or any part thereof or income therefrom, other than the Permitted Encumbrances. Mortgager shall not, without the prior written consent of Mortgagee, modify the terms of any existing indebtedness which constitutes a Permitted Encumbrance hereunder.
- 4.9 Representations and Covenants of Mortgagor. Mortgagor hereby represents and covenants to Mortgagee that: (a) Mortgagor has good and marketable title in fee simple to the Mortgaged Property, (rec) and clear of any prior assignment, mortgages, liens, charges, encumbrances, security interests and adverse claims whatsoever, except the Permitted Encumbrances; (b) to the best of Mortgagor's knowledge, no assignment, mortgages, liens, charges, encumbrances, security interests or adverse claims affect the Mortgaged Property as of the date of this Mortgage, other than the Permitted Encumbrances; (c) as of the date of this Mortgage, the outstanding principal balance of each of the Permitted Encumbrances is accurately reflected on Exhibit B attached hereto and made a part hereof; (d) there are no Leases presently existing and Mortgagor agrees to execute a collateral assignment of any Leases which may exist in the future or of its right, title, interest therein. Breach of such representations and covenants shall constitute an Event of Default hereunder; (e) the Indebtedness, Guaranty, Note, Loan Documents, Obligations, Mortgage and any accompanying loan hereto, has been made in compliance with all applicable federal and state laws, rules, and/or regulations (including but not necessarily limited to, any predatory lending law(s)/statute(s), truth-inlending, RESPA law(s)/statute(s), Regulation B, flood insurance law(s)/statute(s), privates mortgage insurance law(s)/statute(s), appraisal and non-discriminatory lending law(s)/statute(s), practiced as from time to time and as amended); (f) there is no 1) pending or existing special tax (real estate or otherwise) or assessment levied or to be levied

against or affecting the property, 2) condemnation or eminent domain proceedings, 3) pending or threatened litigation, governmental proceeding or like proceeding respecting or affecting the property, nor is there any basis known for any of the aforementioned action(s); and (g) any information and/or documents provide by Borrower, Mortgagor, and all others, including Guarantors, in connection with this transaction are accurate and complete.

4.10 <u>Mechanics Lien</u>. Mortgagor shall not permit or suffer any mechanics lien claims to be filed or otherwise asserted against the Mortgaged Property and Mortgagor shall promptly, and in any event within thirty (30) days after filing, discharge or cause to be discharged the same in case of the filing of any claims for lien or proceedings for the enforcement thereof; <u>provided</u>, <u>however</u>, that in connection with any such lien or claim which Mortgagor may in good faith desire to contest, Mortgagor may contest the same by appropriate legal proceedings diligently prosecuted, but only if Mortgagor shall provide such security and indemnification to Mortgagee in a form and amount deemed adequate by Mortgagee.

Article 5

EVENTS OF DEFAULT

5. <u>Eve</u>nts of Default

The term "Event(s) of Default", as used herein, shall mean the occurrence or happening, from time to time, of any one or more of the following:

- 5.1 <u>Default by Borrower</u>. If Borrower shall default (after notice and expiration of any applicable cure period) in its payment or performance obligations under the Note or other Loan Documents.
- 5.2 <u>Payment of Indebtedness</u>. If Mortgagor shall default in the payment of any Indebtedness due under the Guaranty or this Mortgage
- 5.3 <u>Performance of Obligations.</u> If Mortgagor shall default in the due observance or performance of any of the Obligations and such default shall not be curable, or if curable shall continue for a period of thirty (30) days after written notice thereof pursuant to Section 7.3 hereof.
- Bankruptcy, Receivership, Insolvency, Etc. If voluntary or involuntary proceedings under the Federal Bankruptcy Code, as amended, shall be commenced by or against Mortgagor of bankruptcy, receivership, insolvency, reorganization, dissolution, liquidation or other similar proceedings shall be instituted by or against the Mortgagor with respect to all or any part of Mortgagor's property under the Federal Bankruptcy Code, as amended, or other law of the United States or of any state or other competent jurisdiction, and if such proceedings are instituted against Mortgagor it shall consent thereto or shall fail to cause the same to be discharged within sixty (60) days of filing.
- 5.5 <u>Laws Affecting Obligations and Indebtedness.</u> If subsequent to the date of this Mortgage, any governmental entity in which the Mortgaged Property is located passes any law (i) which renders payment of the Indeptedness and/or performance of the Obligations by Mortgagor unlawful, or (ii) which prohibits Mortgagee from exercising any of its material rights and remedies in this Mortgage
- 5.6 <u>False Representation</u>. If any representation or warranty made by Mortgagor in, under or pursuant to this Mortgage, shall prove to have been false or misleading in any material respect as of the date on which such representation or warranty was made.
- 5.7 <u>Default Under Other Mortgage.</u> If the holder of any other mortgage or any other lien on the Mortgaged Property (without hereby implying Mortgagee's consent to any such other mortgage or lien other than the Permitted Encumbrances) institutes foreclosure or other proceedings for the enforcement of its remedies thereunder, or if a default exists under any other mortgage or lien on the Mortgaged Property.
 - 5.8 <u>Due On Sale</u>. If, without the prior written consent of Mortgagee, there is (i) sale, transfer, agreement for

deed, conveyance, assignment, hypothecation or encumbrance, whether voluntary or involuntary, of all or part of the Mortgaged Property or any interest therein, (ii) any sale, assignment, pledge, encumbrance or transfer to a third party of all or any part of the membership interests in the Mortgagor, or (iii) the seizure of the Mortgaged Property or attachment of any lien thereon, whether voluntary or involuntary, which has not been removed or bonded over, to Mortgagee's satisfaction, within ten (10) days of such attachment, (iv) obtaining by Mortgagor, of any ownership, via purchase, sale, transfer or otherwise, in whole or in part, over any other real property other than the Mortgaged Property, or (v) execution/incurring of any other note(s), mortgage(s), debt(s), and/or liability(ies) in relation to the Mortgaged Property or any other property, whether real property or personal property, other than the Indebtedness.

Article 6

DEFAULT AND FORECLOSURE

- 6.1 <u>Penedies.</u> If an Event of Default shall occur, Mortgagee may, at its option, exercise one or more or all of the following remedics:
 - 6.1.1 <u>Acceleration</u>. Declare the unpaid portion of the Indebtedness to be immediately due and payable, without further notice of demand, whereupon the same shall become immediately due and payable.
 - 6.1.2 Entry on Mortgaged Property. Enter upon the Mortgaged Property, take possession thereof, and exercise any and all remedies set with in this Mortgage.
 - 6.1.3 Operation of Mortgageu Fronerty. Hold, lease, operate or otherwise use or permit the use of the Mortgaged Property, or any portion thereof in such manner, for such time and upon such terms as Mortgagee may deem to be in its best interest (making such repairs, alterations, additions and improvements thereto, from time to time, as Mortgagee shall deem necessary or desircole) and collect and retain all earnings, rents, profits or other amounts payable in connection therewith.
 - 6.1.4 Enforcement of Mortgage. Mortgagee, with or without entry, personally or by their agents or attorneys, insofar as applicable may: (a) sell the Mortgaged Property and all estate, right, title and interest, claim and demand therein, and right of redemption thereof, to the extent provided by and pursuant to the procedures provided by law, at one or more sales, and at such time and place upon such terms and after such notice thereof as may be required or permitted by law; (b) institute proceedings for the complete or partial foreclosure of this Mortgage; or (c) take such steps to protect and enforce their rights whether by ration, suit or proceeding in equity or at law for the specific performance of any covenant, condition or agreement in the Guaranty or in this Mortgage (without being required to foreclose this Mortgage) or in aid of the execution of any power herein granted, or for any foreclosure hereunder, or for the enforcement of any other appropriate legal or equitable remedy or otherwise as Mortgagee shall elect.
 - 6.1.5 <u>Foreclosure and Private Sale.</u> Sell the Mortgaged Property, in whole or in pair, (a) under the judgment or decree of a court of competent jurisdiction, or (b) at public auction (if permitted by the laws of the jurisdiction in which the Mortgaged Property is situated) in such manner, at such time or times and upon such terms as Mortgagee may determine, or as provided by law; at one or more public or private sales, in such manner, at such time or times and upon such terms as Mortgagee may determine, or as provided by law.
 - 6.1.6 Receiver. Mortgagee shall be entitled, as a matter of strict right, and without regard to the value or occupancy of the security, or the solvency of the Mortgagor, or the adequacy of the Mortgaged Property as security for the payment of the Indebtedness and the performance of Mortgagor's Obligations, to have a receiver appointed to enter upon and take possession of the Mortgaged Property, collect the Rents and profits therefrom and apply the same as the court may direct such receiver to have all the rights and powers permitted under the laws of the State where the Mortgaged Property is located. Mortgagor hereby waives any requirements on the receiver or Mortgagee to post any surety or other bond. The expense (including the receiver's fees, counsel fees, costs and agent's compensation) incurred pursuant to the powers herein contained shall be secured by this Mortgage.

Mortgagee shall (after payment of all costs and expenses incurred) apply such Rents, issues and profits received by it to the costs of the Indebtedness. The right to enter and take possession of the Mortgaged Property, to manage and operate the same, and to collect the Rents, issues and profits thereof, whether by receiver or otherwise, shall be cumulative to any other right or remedy hereunder or afforded by law, and may be exercised concurrently therewith or independently thereof. Mortgagee shall be liable to account only for such Rents, issues and profits actually received by Mortgagee.

- 6.1.7 <u>Deed in Lieu of Foreclosure Pursuant to 735 ILCS 15-1401.</u> Upon an Event of Default by Mortgagor, as set forth herein, Mortgagee and Mortgagor may agree to termination of Mortgagee's interest hereunder in the Mortgaged Property, via deed in lieu of foreclosure pursuant to 735 ILCS 15-1401, subject to any other claims or liens affecting the Mortgaged Property. Execution, tender or recordation of a deed in lieu of foreclosure by Mortgagor shall not constitute acceptance by the Mortgagee of said deed in lieu of foreclosure. Acceptance of a deed in lieu of foreclosure by Mortgagee shall only be effectuated by the execution, by both Mortgagor and Mortgagor, of an agreement for deed in lieu of foreclosure.
- 6.1.8 Ariditional Rights and Remedies. With notice, and without releasing Mortgagor from any Indebtedness of Christians, and without becoming a mortgagee in possession, Mortgagee shall have the right to cure any breach or default of Mortgagor and, in connection therewith, to enter upon the Mortgaged Property and to do such acts and things as Mortgagee deems necessary or desirable to protect the security hereof including, but without limitation to appear in and defend any action or proceeding purporting to affect the security hereof or the rights or powers of Mortgagee hereunder; to pay, purchase, contest or compromise any encumbrance, charge, lien or claim of lien which, in the judgment of Mortgagee, is prior or superior hereto, the judgment of Mortgagee being conclusive as between the parties hereto, to obtain insurance to pay any premiums or charges with respect to insurance required to be carried hereunder; and to employ counsel, accountants, contractors and other appropriate persons to assist them.
- 6.1.9 Other. Exercise any other remedy now or hereafter existing in equity, at law, by virtue of statute or otherwise.
- 6.2 <u>Remedies Cumulative and Concurrent</u>. The rights and remedies of Mortgagee as provided in the Guaranty and this Mortgage shall be cumulative and concurrent and may be pursued separately, successively or together against Mortgager or against other obligors or against the Mortgaged Property, or any one or more of them, at the sole discretion of Mortgagee, and may be exercised as often as occasion therefor shall arise. The fail or to exercise any such right or remedy shall in no event be construed as a waiver or release thereof, nor shall the choice of one remedy be deemed an election of remedies to the exclusion of other remedies.
- 6.3 No Cure or Waiver. Neither Mortgagee's nor any receiver's entry upon and taking possession of all or any part of the Mortgaged Property, nor any collection of rents, issues, profits, insurance proceeds, condemnation proceeds or damages, other security or proceeds of other security, or other sums, nor the application of any collected sum to any Indebtedness and Obligations, nor the exercise of any other right or remedy by Mortgagee or any receive shall impair the status of the security, or cure or waive any default or notice of default under this Mortgage, or nullify the effect of any notice of default or sale or prejudice Mortgagee in the exercise of any right or remedy, or be construed as an affirmation by Mortgagee of any tenancy, lease or option or a subordination of the lien of this Mortgage.
- 6.4 Payment of Costs, Expenses and Attorneys' Fees.  - 6.5 <u>Waiver of Redemption, Notice and Marshaling.</u> To the extent permitted by law, Mortgagor hereby waives

MISCELLANEOUS

- 7.1 Further Assurances.
