LEGAL DESCRIPTION

Legal Description: Parcel I:

Rees Subdivision of the South 10 rods of the North 40 rods of the East half of the Northeast quarter of Section 17, Township 40 North, Range 12 East of the Third Principal Meridian, which plat of survey is attached as Exhibit "C" to the declaration of condominium ownership recorded June 4, 2007, as document no. 0715515066, as amended from time to time, together with its undivided percentage interest in the common elements, all in Cook County, Illinois.

Easements appurtenant to and for the benefit of Parcel I as set forth and defined in the declaration of covenants, restrictions and easements recorded as document no. 0715515065 for ingress and egress, all in Cook County, Illinois.

'grantor also hereby grants to the grantee, its successors and assigns, as rights and easements appurtenant to the subject unit described herein, the rights and easements for the benefit of said unit set forth in the declaration of condominium; and grantor reserves to itself, its successors and assigns, the rights and easements set forth in said declaration for the benefit of the remaining property described therein. This deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said declaration the same as though the provisions of said declaration were recited and stipulated at length herein.'

'mortgagor also hereby grants to the mortgagee, its successors and assigns, as rights and easements appurtenant to the subject unit described herein, the rights and easements for the benefit of said land set forth in the declaration of condominium. This mortgage is subject to all rights, easements, covenants, restrictions and reservations contained in said declaration the same as though the provisions of said declaration were recited and stipulated at length herein.'

EXHIBIT B

(1) real estate taxes and installments of special taxes and assessments not yet due and payable; (2) zoning, building and use restriction laws or ordinances; (3) all rights, easements, restrictions, conditions, covenants and reservations of record including without limitation as contained in the Declaration and a reservation by Sheridan Place in Uptown Condominium Association to itself and its successors and assigns, for the benefit of all Unit owners at the Condominium, of the rights and easements set forth in said Declaration, as the same may be amended from time to time; (4) public, private and utility easements; (5) provisions of the Condominium Property Act of Illinois; (6) roads and highways; (7) acts done or suffered by party of the second part; and (8) such other exceptions contained in the title policy issued to and accepted by party of the second part contemporaneously with the execution and recordation of this deed and insuring party of the second part's interest in the described real estate. The rights, easements, restrictions, conditions, covenants and reservations of record reserved in (3) above include, without limitation, the right to automatically change such percentage interest in accordance with such amendments as they are filed of record pursuant to said Declaration, and together with additional Common Elements as such amendments are filed of record, in the percentages set forth in such amendments, which percentages shall automatically be deemed to be conveyed effective on the recording of each such amendment as though conveyed hereby. The deed is conveyed on the conditional limitation that the percentage of ownership of the grantees in the Common Elements shall be divested pro tanto and vest in the grantees of the other Units in accordance with the terms of the Declaration and any such amendments recorded pursuant thereto, and the right of revocation is also hereby reserved to party of the first part herein to accomplish this result. The acceptance of this conveyance by the grantees shall be deemed an agreement within the contemplation of the Condominium Property Act of the State of Illinois to a shifting of the Common Elements pursuant to the Declaration and to all the other terms of the Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of each such amendment recorded pursuant thereto. The party of the first part reserves to itself and its successors and assigns the rights and easements set forth in the Declaration for the benefit of the Additional Property, as defined therein.
