TENANCY BY THE ENTIRETY WARRANTY DEED Statutory (Illinois)

of Chicago, Illinois, not as Tenants in Common nor at Joint Tenants but as Tenants by the Entirety, all right, title, and interest in the following described real estate situated in the County of COOK, State of Illinois, to wit:

Parcel 1: The North 21.96 feet of the South 154.91 feet of the following described tract: That part of Block 9 in Dearborn Park Unit No. 2, being a Resubdivision of sundry lots and vacated streets and all ys, in part of the Northeast 1/4 of Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, described as follows: Beginning at the Northeast corner of Block 9, aforesaid; thence South 00 degrees 08 minutes 18 seconds West along the East line there of, 287.91 feet; thence North 89 degrees 51 minutes 42 seconds West at right angles thereto, 76.0 feet; thence North 00 degrees 08 minutes 18 seconds East parallel with said East line, 287.58 feet to the North line of said Block; thence North 23 degrees 53 minutes 11 seconds East along said North line, 76.0 feet to the point of beginning, in Cook County, Illinois.
