This Driveway Agreement is made this 22nd day of August, 2008, by and between Peter M. Sharnon III and Shannon S. Shannon (collectively referred to as "the Shannons") and Anne M. Shannon as Trustee of the Anne M. Shannon Trust under Agreement dated July 13, 1995 ("Shannon Trust").

WHEREAS, the Shannons are the owners of two parcels of real estate commonly known as 4542 Wolf Road, Western Springs, Illinois and legally described on Exhibit A attached hereto ("Shannon Property");

WHEREAS, the Shannon Trust is the owner of a parcel of real estate commonly known as 4546 Wolf Road, Western Springs, Illinois and legally described on Exhibit A attached hereto ("Shannon Trust Property");

WHEREAS, the Shannons desire to construct a driveway adjacent to the Shannon Trust Property which will use a part of the right-ci-way for Wolf Road adjacent to the easterly boundary of the Shannon Trust Property and the Shannon Trust desires to consent to that use on the terms and conditions set forth herein.

NOW THEREFORE, in consideration of ten dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. <u>Incorporation of Recitals</u>. The foregoing recitals are incorporated by reference as though fully restated herein.
- 2. Consent to Use of Right of Way. The Shannon Trust hereby consents to the Shannons' use of the right-of-way area adjacent to the Shannon Trust Property and in such configuration as the authorities having jurisdiction may approve.
- 3. **Maintenance**. The Shannons and the Shannon Trust agree that each party shall be responsible for maintenance and replacement of their own driveways and any areas of same between their property boundaries and Wolf Road.
- 4. <u>Future Modifications to Driveways</u>. If the Shannons or the Shannon Trust or their respective successors or assigns remove or modify the driveways adjacent to the other, each agrees that the other shall be permitted to maintain their driveway and use the right-of-way area in accordance with this Agreement.

5. <u>Successors and Assigns</u>. This Agreement shall be recorded against the Shannon Property and the Shannon Trust Property and shall be binding upon their successors and assigns.
