MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT is made this 23 day of JULY, 2008, by and between the VILLAGE OF GLENCOE, an Illinois special charter municipal corporation ("Village") and CARMAX AUTO SUPERSTORES, INC., (Virginia corporation ("CarMax") (collectively, the "Parties").

RECITALS

A. The Parties have entered into a certain "Settlement Agreement" lated as of the 23d day of 5vey, 2008, arising out of an action filed in the Circuit Cour. of Cook County, Illinois, styled "Village of Glencoe v. CarMax Superstores, Inc.," Case No. 2007 M2 2001076, which action was removed to the United States District Court for the Northern District of Illinois and is now identified as Case No. 07 C 3366 (the "Lawsuit").

B. The Lawsuit involves, *inter alia*, disputes between the Parties concerning the sale and development of a parcel of land within the Village legally described in the attached Exhibit 1 ("*Property*"), and particularly issues arising from the sales contract between the Parties (the

"Purchase and Sale Agreement"), related development activities, and tax reimbursement issues.

C. The Settlement Agreement resolves the Parties' disputes, provides for the dismissal of the Lawsuit, and, inter alia, provides for a "Restated Development and Economic Incentive

Reimbursement Agreement" between the Parties.

NOW, THEREFORE, for and in consideration of the mutual promises, covenants, and conditions hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby enter into the following:

MEMORANDUM OF AGREEMENT

1. This Memorandum of Agreement has been executed and delivered by the Parties for the purpose of recording and giving notice that the Farties have entered into a contractual relationship pursuant to the Settlement Agreement.

2. This Memorandum of Agreement will be recorded immediately after the date first above written and is intended for notice purposes. References must be made to the Settlement Agreement for the full terms and provisions thereof.
