That "Construction Design", entered into a written Contract with Chicago Masonry Construction, Inc., ("Chicago Masonry") whereby Claimant agreed to furnish masonry material and labor to "Construction Design" in exchange for payment in the original contract amount of Four-Hundred and One Thousand, Seven-Hundred and Sixty Fight Dollars & 00/100, (\$401,768.00).
- 4. That the Subcontract was entered into between "Construction Design" and "Chicago Masonry" with the full knowledge and consent of the Owner and, or Tenant. Claimant completed providing the additional materials and labor at various times.

 - 7. That deletions were made to the original contract in the amount of \$893.00.
