MODIFICATION OF MORTGAGE AND OTHER SECURITY DOCUMENTS

THIS MODIFICATION OF MORTGAGE AND OTHER SECURITY DOCUMENTS ("Modification") is made effective as of the 26th day of March, 2008 by TLC Huron Lofts Residential, LLC, an Illinois limited liability company and LF Huron, LLC, an Illinois limited liability company, each with a mailing address at 1033 West Van Buren Street, Chicago, Illinois 60607 (collectively, "Mortgagor") to and for the benefit of MB FINANCIAL BANK, N.A. ("Mortgagee"), with a mailing address of 611. North River Road, Rosemont, Illinois 60018, Attention: Vincent G. Laughlin.

RECITALS:

WHEREAS, Mortgagee has heretofore made a mortgage loan (the "Loan") to Huron Street Associates LLC, an Illinois limited liability company ("Huron") in the original principal amount of TWO MILLION NINE HUNDRED EIGHTY TIMEE THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$2,983,500.00); and

WHEREAS, the Loan is evidenced by a Mortgage Note dated as of March 26, 2007 (the "Note") made by Huron whereby Huron promised to pay to the order of Mortgage, the principal sum of TWO MILLION NINE HUNDRED EIGHTY THREE THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$2,983,500.00), all as more specifically set forth in said Note; and

WHEREAS, the Note is secured by, among other things, a Mortgage, Assignment of Leases and Rents, and Security Agreement dated as of the 26th day of March, 2007 by Huron in favor of Mortgagee, recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on March 29, 2007 as Document No. 0708857180 (the "Mortgage") and a Guaranty of Payment dated as of the 26th day of March, 2007 (the "Guaranty") by KEITH E. LORD ("Guarantor") in favor of Mortgagee; and any and all other instruments and documents executed by or on behalf of Huron and delivered to Mortgagee in connection with the Loan, which are hereinafter collectively referred to as the "Other Security Documents"; and

WHEREAS, on or about March 19, 2008, Huron conveyed the Property (as defined in the Mortgage) to TLC Huron Lofts Residential, LLC, an Illinois limited liability company and LF Huron, LLC, an Illinois limited liability company;

WHEREAS, Mortgagor desires that the Loan be modified to change the Mortgagor, extend the Maturity Date and to decrease the amount of the Loan; and

WHEREAS, the parties desire to modify and amend the terms of the Loan as provided herein and as a condition to such modification, Mortgagee is requiring: (i) this Modification; (ii) an Amendment to Mortgage Note dated of even date herewith executed by Mortgagor (the "Note Amendment") whereby the Note is modified as provided above; and (iii) a Consent and Reaffirmation of Guarantor and Modification of Guaranty of Payment executed by Guarantor ("Guaranty Modification") whereby the Guaranty is modified to secure the Note as modified by the Note Amendment.

NOW, THEREFORE. for and in consideration of Ten and 00/100 Dollars (\$10.00) in hand paid, the mutual covenants and conditions herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto do hereby agree as follows:

- 1. <u>Incorporation of Recitals</u>. The aforesaid recitals are hereby incorporated into this Modification by reference as if fully set forth in this Paragraph 1. Wherever the terms and conditions of this Modification conflict with the terms and conditions of the Mortgage, the terms and conditions of this Modification shall control. In all other respects the parties do hereby ratify and declare to be in full force and effect the terms and conditions of the Mortgage and the Other Security Documents.
- 2. <u>Modification of Mortgage and Other Security Documents</u>. The Mortgage and Other Security Documents are hereby modified by as follows:
 - a. to provide that all references to "Mortgagor" contained in the Mortgage and Other Security Documents are hereby deemed, for all purposes, to collectively refer to and include "TLC Huron Lofts Residential, LLC, an Illinois limited liability company and LF Huron, LLC, an Illinois limited liability company"
 - b. by deleting the amount "Two Million Nine Hundred Eighty Three Thousand Five Hundred And 00/100 Dollars (\$2,983,500.00)" where it appears and substituting therefor the amount "One Million Five Hundred Twenty Eight Thousand Five Hundred Thirty Two and 00/100 Dollars (\$1,528,532.00)"
 - c. by deleting the date "March 26, 2008" where it appears and substituting therefor "July 24, 2008"
- 3. References to Note. From and after the date hereof (i) the Mortgage, the Assignment and the Other Security Documents shall be deemed to secure the Note as modified by the Note Amendment; and (ii) any and all references in the Mortgage or the Other Security

Documents to the "Note" shall be deemed to refer to the Note as modified by the Note Amendment.

- 4. References to Loan Documents and Guaranty. Any and all references in the Note, the Mortgage and the Other Security Documents to the "Loan Documents" shall from and after the date hereof be deemed to refer to such Loan Documents as modified by this Modification: and any and all references in the Note, the Mortgage and the Other Security Documents to the "Guaranty" shall from and after the date hereof be deemed to refer to the Guaranty as modified by the Guaranty Modification.
- 5. Reaffirmation of Representations and Warranties. Mortgagor hereby reaffirms as true and correct in all respects, as of the date hereof, any and all representations and warranties contained in the Mortgage and the Other Security Documents.
- 6. Reaffirination of Covenants. TLC Huron Lofts Residential, LLC, an Illinois limited liability company and LF Huron, LLC, an Illinois limited liability company hereby agree to comply with all of the terms, undertakings and conditions of the Loan Documents as if they were original signatories there o and hereby reaffirm and agree to perform all of the terms, covenants, conditions and obligations applicable to such parties as set forth in the Mortgage and the Other Security Documents as herein modified.
- 7. <u>Laws of Illinois</u>. This Mcdification shall be covered and construed under the laws of the State of Illinois.
