MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated December 15, 2007, is made and executed between AVENUE RIDGE, LLC, whose address is 8320 SKOKIE BOULEVARD, SKOKIE, IL 60077 (referred to below as "Grantor") and BRICKYARD BANK, whose address is 6676 N. MORTGAGE. Lender and Grantor have entered into a Mortgage dated June 15, 2006 (the "Mortgage") which has been recorded in COOK County, State of Illinois, as follows:

EXTEND ADDITIONAL FUNDS IN THE AMOUNT OF \$139,397.23 AND EXTEND MATURITY DATE TO DECEMBER 15, 2008. THIS MODIFICATION IS EVIDENCED BY A PROMISSORY NOTE DATED DECEMBER 15, 2007 IN THE AMOUNT OF \$2,176,251,71.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in

Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
